## RULES INTERNATIONAL PADEL EXPERIENCE BY MADISON 2016

# 1. - PLACE AND DATE.

The padel tournament in will be held on Friday, Saturday and Sunday. The first games to play during the day on Friday, will be held on Friday from 18.00 (depending on the final number of players), while Sunday's final rounds scheduled.

# 2. - PARTICIPANTS AND CATEGORIES.

The International Padel Experience by Madison is a paddle amateur circuit. All tournaments are open to the participation of players of national and international field, not only confined to local or regional level. You can participate any player older and are not included in the top 100 positions of certain rankings.

To participate in the tournament will have processed registration required by Monday before the start of the competition. The categories are reserved for couples of any sex, the female categories being aimed solely at women:

## CATEGORIES or DIVISIONS:

- Men's Open A
- Men's Open B
- Men's Open C
- Women's Open A
- Women's Open B
- Mixed Open A

It is the obligation of the couples enrolled its level adjustment allocated to each category. The organization is empowered to reject participation in the Tournament of the players who do not meet the standards set for each category. Notes:

Power of the organization will reassign couples participating in either category depending on their level in order to obtain groups and categories as balanced as possible.

Each category must have a minimum of 6 registered partners. Failure to reach that figure may reallocate organization such couples, upon acceptance of the same-in other categories.

### 3. - COMPETITION FORMAT.

The competition format is table elimination with consolation in each category (minimum two-game guarantee Tournament).

The group matches will be played the first to win two sets, each lasting approximately one hour. In case of draw will be decided in a tie-break to 11 points.

In case the registration is low, the organization reserves the right to change the game system you can choose from:

• System groups playoffs with final table (guarantee minimum two-game tournament). After each group of system groups the top two from each group advance to the semifinals in its class, to be played on Sunday.

The group matches will be played the first to win two sets, each lasting approximately one hour. In case of a draw will be decided in a tie-break to 11 points.

The semifinals and final in each category will be played best of three sets, with the best tiebreak 7 points in case of tie at 6 games in each set.

Note: If you accumulate a delay in the competition schedule for the day on Saturday, the organization is empowered to slightly modify the format of the games in the day on Sunday in order to achieve completion of the tournament schedule.

#### 4. – SCHEDULES AND COMPETITION BOX.

Friday's session will start at 18.00, with scheduled start of the matches on Saturday and Sunday at 9.00 am.

Table and competition schedules will be posted on the internet (in http://internationalpadel.com/ Championship microsite) and mail 24 hours before the start of the competition.

Once start the tournament, if force majeure beyond the organization of the latter had to be postponed, pending rounds would be played later in the day, having to bend round on the same day.

The organization reserves the right to change schedules to suit the availability of the participating couples. In case of any change of schedule involving a game, the players involved will be notified telephone or in person during the competition with enough advance time to present (at the beginning of the previous match) to your match.

Failing agreement between the partners rivals matches will be played according to the official calendar posted prior to the tournament.

Each match will have 5 minutes of warm-up. If a couple is not present on time for the match after complimentary 10 minutes, the couple will have after this time a WO (Walk Over) and the couple will loss the match. If the couple has between 1 and 5 minutes of delay, no right to warm-up during lost minutes. In case of delay between minutes 6 and 10 no right to warm-up.

## 5. - AWARDS.

The awards and any other gift or sweepstakes will be notified on the website of the tournament.

#### 6. - PRICE AND REGISTRATION.

The registration fee for the International Padel Tournament Challenge by Madison will be published in the official web, not considered valid until payment has been made of it. Places are limited and will be accepted in chronological order of registration. Entries can be made until Monday before the start of each tournament to 17.00 hours (local time) through:

- The competition website <u>http://internationalpadel.com/</u>.
- Via the Club which hosts the tournament.

If we receive a request for inclusion in a category already closed, the couple would stay on the waiting list and does not require the payment of registration until final inclusion in the tournament.

## 7. - INJURY OR NO-SHOWS.

If during the course of the tournament result proved the injury of a player, your partner may submit a substitute at the start of the next match.

If the injury occurred during the course of a match the injured player will have 10 minutes to return to the match, or 20 (from the notification of the injury) to find a replacement.

If the injured player is unable to resume competition in the next match be 4 allowed to participate substitute player short for the remainder of the competition, becoming regarded as the couple's starting player.

In all cases, the replacement must be of equal or similar level to the injured player, not being allowed to participate for the purpose of another player still in competition. It is not allowed more than a replacement the couple injury throughout the competition. If the couple is not substitute for the injured player or have a new injury, lost the remaining matches of the tournament.

Any couple of the tournament can claim that player a substitute opponent have a level slightly higher than the injured player. In that case will entitle the case study organization and the possible elimination of the offending partner.

#### 8. - PENALTIES.

1. Being more than 5 minutes late to a mach. Loss of a set.

2. Being more than 10 minutes late to a mach. Loss of the match.

3. Failure to attend a mach and not tell. Elimination of the tournament.

4. Breaking the rules of fair play. Elimination of the tournament.

5. Change partners during the stage. Elimination of the tournament, unless justification valid, previously evaluated by the organizers (see point 7).

6. Bad behavior on the facilities. Elimination of the tournament. The tournament organizers may remove players who do not comply with the rules of civility or any other reason that harms the development of the event and respect for people and facilities. The tournament organizers may remove players who are deemed to have committed irregularities during the registration process, especially relevant to the assignment of the level of each one of the members of the couple.

## 9- ARBITRATION.

The players involved in the game dispute arbitration shall be liable thereof, being essential that in case of suspension of the meeting or incidents of the same, these are communicated to the organization. One player of the couple must report the result of the mach leaving the exhibition signed. The tournament will be conducted under the rules expressed in current official paddle.

## 10.- RANKING.

In each round of the tournament will be awarded some points valid for the final ranking of the circuit. If the women's and mixed, only apply the ranking of the first category. In case you realized group stage because there is a very low turnout, apply the same amount of points, with the score <sup>1</sup>/<sub>4</sub>, 1/8 and 1/16 for the second, third and fourth place of each group as classified finishers from the semifinals.
